

## Video Testimonial Initiative Terms and Conditions:

The date that we announce the video testimonial prize recipients will be influenced by the number of videos we get and the date we receive them.

- 1. Eligibility: This initiative is open only to those who sign up. The initiative is only open to legal Nonprofit Organizations in the US and Canada, and is void where prohibited by law. Employees of CharityHowTo, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the initiative.
